### REGISTRATION FEES AND DATES:

Registration: **May 26 – June 8, \$175**

Late Registration: on or after June 9 – \$175 + \$50 Late Fee

- Player registration is not complete until all paperwork is submitted to FYFA and registration fees are paid to WPRD.

### EQUIPMENT REQUIREMENTS

#### FYFA PROVIDED EQUIPMENT:

The following are provided and issued by FYFA for use by the player during the season:

- Shoulder pads
- Helmet & chin strap
- Game jersey
- Practice jersey

#### PLAYER PROVIDED EQUIPMENT:

These items must be purchased by the parent/guardian, they are required for the participant

- Black Football pants for games; any color can be worn for practice
- Football cleats - molded, with non-metal and non-removable cleats
- Mouth guard (NOTE: Clear mouth guards are NOT allowed by league)
- Athletic supporter and cup

*\*Misc. Used pants & cleats may be available during equipment pick-up\**

### IMPORTANT DATES

- July 15th- Equipment Pick Up Event #1 from **6-8pm** at the lower level of the Spec Pond Concession Stand
- July 28th – Equipment Pick Up Event #2 from **6-8pm** at the lower level of the Spec Pond Concession Stand
- Friday, August 3 – Pre-Season Practice Begins and then **Mon - Thurs 6-7:45** @ Spec Pond until school starts
- August 6 - Parent's meeting @ Spec Pond, time TBD (**highly encouraged for new & existing players**)
- August 13th – **Mandatory** weigh-in at Memorial School @ 6 pm. Coaches will determine if your player needs to attend. If a required player misses SAFL weigh-ins they will play as an “over” player (lineman). *Practice will be held following weigh-ins.*
- August 22 - Pre-Season Scrimmage at Spec Pond, time TBD
- September 1 - Regular Season Practice Begins (**Tues/Weds/Fri, time TBD by Coach**) at Spec Pond
- September - November – Games start **Labor Day Weekend** and Playoffs run into mid-November. (Generally, JV games are on Saturday and Varsity games are on Saturday evening or Sunday)

## Adult Code of Conduct and Ethics Contract

I hereby pledge to provide positive support, care and encouragement for my child and other children participating within this program by following this Code of Conduct and Ethics to help establish a positive experience for all players, coaches, and families involved.

1. I will encourage and demonstrate by example the importance of good sportsmanship, respect and positive support for all players, coaches, officials, and volunteers at practices and games.
2. I will help teach the value of commitment to the teams, sportsmanship, ethical conduct and fair play.
3. I will place the emotional and physical well-being of my child over my personal desire to win.
4. I will abide by a doctor's decision in all matters of players health and injuries and physical ability to play.
5. I will demand a sports environment for my child that is free from drugs, tobacco and alcohol and I will refrain from their use at all sporting events.
6. I will learn the rules of the game and the policies of the league and assist in teaching my child that rules are important and must be followed.
7. I will teach my child to resolve conflicts without resorting to hostility or violence.
8. I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all.
9. I will demand that my child treat other players, coaches, officials, and spectators with respect.
10. I understand that verbal and physical abuse including profanity and foul language is not to be tolerated against anyone in this organization.
11. I understand that racial epithets or negative innuendo related to a person/players race, religion or ethnicity will not be tolerated.
12. I will not create conflict by slander, malicious rumors or threats, nor will I entice others to do so either verbally or through social media.
13. I will respect the officials and their authority during games and will never question, discuss or confront coaches at the game and will take time to voice my concerns at a later time with the coach, using the 24 hour rule as a guideline.
14. I will support my child's coach and refrain from excessive "sideline coaching" from the stands.
15. I will accept the decisions of officials on the field as being fair and called to the best ability of the officials.
16. I will inform the coach of any physical disability or special needs that may affect the safety of my child or the safety of others.

**I fully understand and completely accept the standards of behavior outlined in the Adult Code of Conduct and Ethics, for both myself, other family members and guests who may attend FYFA practices, games or activities. I realize that if at any time my behavior, or the behavior of other family members and guests becomes non-compliant with any of these standards, said individual will be subject to disciplinary action that could include, but is not limited to the following:**

- Verbal and/or written warning by the head coach, Wilbraham Parks & Recreation Department or Falcon Youth Football Association Executive Board.
- One or multiple game suspension.
- Indefinite suspension.

Any violation of the following Participant Codes of Conduct and Ethics could result in disciplinary action by the FYFA that may result in warnings or suspension.

**I hereby pledge to be positive about my youth sports experience and accept responsibility for my participation by following this Participant Code of Conduct and Ethics Pledge:**

- I will respect all aspects of the game, including myself, coaches, officials, teammates, opponents, fans and rules, regardless of the behavior of others.
- I will encourage good sportsmanship from fellow players, coaches, officials and parents at every game and practice by demonstrating good sportsmanship.
- I will treat my coaches, other players, officials and fans with respect regardless of race, sex, creed, or abilities and I will expect to be treated accordingly.
- I will remember that sports are an opportunity to learn and have fun, and I will report all problems to my coaches immediately.
- I will support my teammates and be a team player.
- I will do my best to listen to and learn from my coaches.
- I will take responsibility for my own behavior.
- I will attend every practice and game that I can, and will notify my coach if I cannot.
- I understand am expected to arrive at games and practices on time, or to alert my coach if I am going to be late.
- I will abide by the rules and regulations of the game and encourage other athletes to do the same.
